### XIII. New Business

A. AFSCME Contract Negotiations Committee

- C. Discussion and possible action on Long Term Capital Plan
  - The Board received an updated Long Term Capital Improvement Plan for review as well as an estimate on the cost of replacing the 1963 and 1991 pitched roofs. Mr. Ellsworth noted that the Facilities Committee is also looking into the possibility of adding solar to the roof project.

- E. Update on 2020-21 School Calendar
  The Board was advised of the change to the Parent-Teacher Conference dates, from March
  31 and April 1, 2021 to March 25 and 26, 2021. They were advised that March 26, 2021
  will be a half day and April 1, 2021 will now be an asynchronous remote learning day.

Spring Sports Discussion and possible action MOTION: (Ellsworth/Calchera) To support the principal's decision regarding EES Students' participation in school sports and to approve the adjusted timelines for Union students to request to participate in the EES sports program. Motion passed unanimously.
- G. Budget 2021-2022 Discussion and possible action MOTION: (Cote/Skiff) To reduce the 2021-2022 Board of Education budget by \$10,136 and re-submit it to the Board of Selectmen. Motion passed unanimously. There was a discussion held regarding the Freedom of Information Act (FOIA) request made by the First Selectman. The Board agreed to allow Mr. Bowen to work with the Superintendent to determine a timeline and the documentation that would be provided in response to this FOIA request.
